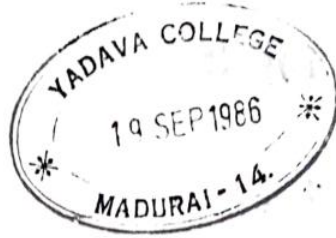

While communicating the above, I am also to inform you that the following recommendations of the Inspection Commission are to be adopted in the development of research work in the above department:-

1. Two Students with stipend from the college funds and two non-stipendiary students may be permitted to register for Ph.D. degree, at a time, under the supervision of recognised supervisors.
2. Tamil reference and research oriented books should be purchased for Rs.5,000/- annually and such amount should be allotted in the budget of the college, to buy up-to-date books in Tamil.
3. To concentrate on such areas of specialisation, which are not done by any other similar institutions.
